SUBJECT: POLICY CONSOLIDATION

REFERENCE: This letter supersedes FSD 00-10.

PURPOSE: The purpose of this letter is to provide a current index of Department of Child Support Services' (DCSS) program policies.

POLICY: The attached index contains letter dispositions that are defined as:

- Current: Current DCSS program policy.
- **Obsolete**: Does not represent current policy.
- Superseded: Obsolete, replaced by another letter or higher authority.
- **Information**: Does not contain a DCSS program directive, however, the information may still be relevant.

BACKGROUND: DCSS initiated the Policy and Procedure Manual Project to provide clear and comprehensive policies and procedures, and promulgate regulations as necessary. As part of this project, the Letter Review Forum workgroup reviewed 1,389 letters (CSS, CSSIN, FSD, FSDIN, E-Blast, PI and LCSA) posted through November 2016 to consolidate and document recommendations on whether each letter was current, obsolete, superseded, or information. Letters with the disposition of "Current" contain at least one provision of current policy within the letter and have not been partially obsoleted.

ACTION: DCSS will update the referenced letters on the department's internal and public websites and begin updating the Statewide Policies Manual to reflect the changes. DCSS will also assess the letters in the index with a disposition of "Current" for regulation development.
